PIT RIVER TRIBAL HOUSING PROGRAMS

BASIC HOMEOWNERSHIP

The Basic Homeownership program is for Tribal Members who reside on Tribal Land Assignments. Through a Tri-Party Agreement with Pit River Tribe; eligible Tribal members maybe be able to have a home built on their land assignment. Under this program PRTHB will build homes within the 100 mile square on a Tribal Land Assignment.

All applications must be complete and all documentation including land control i.e. land assignment must be attached to be eligible. If you have received Housing services within the last 7 years you are not eligible. Pit River Tribal Housing will post open and close dates for this application. Applications must be updated annually to remain active.

Applicant can not have a current home in standard living condition on their land assignment.



WIYACHI VILLAGE

BURNEY, CALIFORNIA

Wiyachi Village is for Elder Pit River Tribal Members. This complex has 18 units, each unit has two bedrooms, one bath and a garage. The Wiyachi Village units are designed for elderly disabled individuals, with walk in showers, grab bars, and wide hallways and door openings. These units are well insulated, some units have solar panels depending on the location of the building and sun coverage. Pit River Health's Senior Nutrition is centralized within the Village where Elders can have a nutritional lunch at the Elders Center.

*Applicant must be 55 years or older to be eligible.
Applications must updated annually to remain active.*

XL FAMILY/ELDER HOUSING

ALTURAS, CALIFORNIA

XL Elder and Family homes are managed under the XL Subdivision rental program through Pit River Tribal Housing Board. Occupied at this time are 4 Elder homes and 4 family homes. One rental is currently under rehabilitation and will be made available as soon as the home is completely rehabilitated. Applications available on our website or you can call our office to have one mailed to you.

Applications must be updated annually to remain active.

Elder Housing: Applicants must be 55 years or older to be eligible.



PIT RIVER TRIBAL HOUSING PROGRAMS

BIA HIP

The Housing Improvement Program is a home repair, renovation, replacement and/or new housing grant program. HIP serves the low income Tribal Members who have substandard housing or no housing. HIP funding is only received once a year, however applications can be submitted all year long. Determinations prior to approval will include a site assessment to decide whether it will be feasible to build a home. Other factors will include, family size, income, site control, age, current living conditions and disability.

Please be advised, Pit River Tribal Housing does not determine who receives funding, we only accept applications, assist in the administration and construction of approved applicants by the Bureau of Indians Affairs.

Please note; that all applicants applying for BIA HIP funds are competing for funds with other tribes nationwide.

REHABILITATION

PRTHB recognizes the need to rehabilitation homes and to address the most serious and detrimental housing conditions of the Pit River People. The goal is to attain decent, safe and sanitary living conditions and improve the quality of life of its members, and provide assistance to those members at the greatest risk to health and safety because of their housing conditions and environment.

Please be advised homeowners are responsible for the maintenance of their homes. PRTHB cannot provide maintenance services; regular maintenance is the responsibility of the homeowner, this includes but not limited to broken windows, painting, cosmetic repairs, septic tank pumping, and normal maintenance repairs, etc.

You can only receive services once every 7 years.

DOWN PAYMENT ASSISTANCE

FOR FIRST TIME HOMEBUYERS

This program is now available. Eligible applicants could receive up to \$20,000 towards the down payment and closing cost of the purchase of a home on fee land. Down Payment Assistance grant is available for use only once in a lifetime. Applicant must qualify as a low income family, first time homebuyer, have obtained a prequalification letter from a lender and no outstanding balances due to the Pit River Tribal Housing or the Pit River Tribe. Pit River Tribal Housing will grant two or three per year.

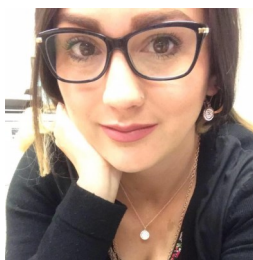

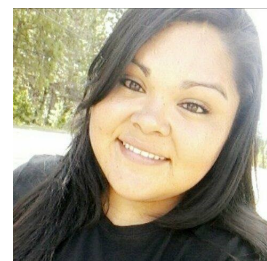

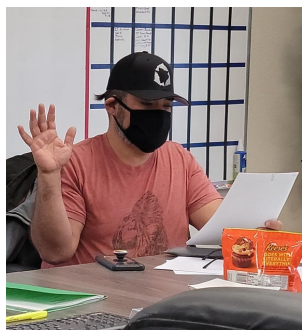

Damion Stedman and Sierra Cabral-Villa.

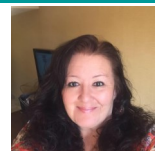


FAREWELL, SHEILA AND CHRIS

HIRING RESIDENTIAL SECURITY GUARDS

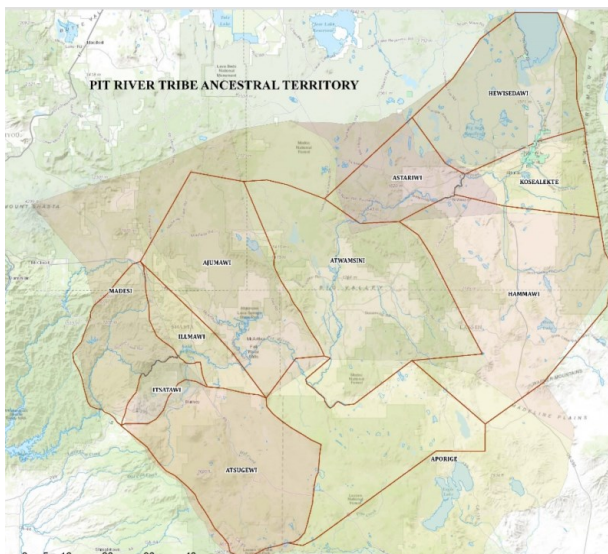

ELDERS CENTER



The PRTHB would like to notify Tribal Members that the Wiyachi Village Elders Center is under the management of the Pit River Tribal Housing Board (PRTHB). To utilize the Building, you must obtain a request form from the Housing Office in Burney. Should your request be approved, there is deposit, Fee and an Agreement that must be signed and paid prior to the Building being opened for use by PRTHB Staff. Responsibility and Access must be approved and coordinated between the Tribal Member and the PRTHB. You may reach the Housing Office at (530) 335-4809, or 20300 Fir Street, Burney, CA 96013.

Please be advised wakes are not allowed within the Elders Center. Funeral receptions are acceptable. Adequate time for approval must be given to avoid conflicts with other schedules. Approved Tribal Member is responsible for the building and all the guest present.

The legal maximum occupancy is 66 people for dining (tables and chairs), 142 people (chairs only). Holidays and days issued as holidays the center will not be available. Renter/User shall pay a security deposit in the amount of \$150.00. Weekdays the center is occupied by Senior Nutrition until 4:30 pm. Individual Tribal Member \$100.00 each day on weekdays/Saturday. \$150.00 with kitchen, Tribal Business/Entity \$250.00 each day on weekdays/Saturday. \$300.00 with kitchen. Pit River Tribal Housing Board reserves the right to waive fees. Requests must be submitted a minimum of three weeks prior to the date of use. Emergency request will be considered. An individual must be 18 years or older to request and sign the agreement. Requests are handled on a first come first served basis. The center will not be reserved until approved, and agreement signed. PRTHB will waive the fees for funeral receptions (only).

I have read and understand the above. I further understand that it is the discretion of PRTHB to approve or deny the request.

I also agree that if approved I will enter into a Use Agreement with the PRTHB.
